Building 100 shows signs of sinking on either end, will wait to see how it settles before making decisions for future mitigation.

Update on the Pinal County School Data Processing ransomeware attack. The department of Homeland Security, Pincal County Sheriff and the FBI have all been involved in this attack. No updated information has been communicated to the districts, the investigation is ongoing as far as we know. We are contracted with Pinal County Data Processing to host our accounting software, but we will be looking into other options for the 2025 school year. We may move to Tyler Technologies to host as the hold data in a cloud-based hosting where it's less susceptible to cyber attacks than a physical data site.
